On March 3, 2018 at approximately 1955 hours Inmate enters the Staff Bathroom. At approximately 1956 hours Officer Royal enters the Staff Bathroom. At approximately 2009 hours Officer Royal exits the Staff Bathroom. At approximately 2010 hours Inmate exits the Staff Bathroom.
