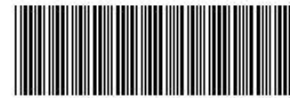

PURSUANT TO A NARCOTICS INVESTIGATION, [REDACTED] CONTACTED ON FRIDAY, JULY 13, 2018 BY A CELLPHONE NUMBER OF [REDACTED] LATER IDENTIFIED AS THE DEFENDANT WHO INITIATED CONTACT VIA TEXT MESSAGE, STATING TO PICK UP SOME THING N \$500 WIT IT. FURTHER TEXT MESSAGES WERE EXCHANGED AND A MEET-UP WAS SCHEDULED FOR TUESDAY, JULY 17, 2018. THE DEFENDANT IS A CURRENT STATE CORRECTIONS OFFICER ASSIGNED TO SOUTH FLORIDA RECEPTION CENTER (STATE PRISON FACILITY) LOCATED IN MIAMI- DADE COUNTY.

ON TUESDAY, JULY 17, 2018, THE DEFENDANT AGREED TO ENGAGE IN THE TRANSACTION AT DOLPHIN MALL LOCATED AT 11401 NW 12TH STREET. ON THE AFOREMENTIONED DATE AT APPROXIMATELY 7:10 PM, [REDACTED] MET WITH THE DEFENDANT AT THE DOLPHIN MALL PARKING LOT. THE DEFENDANT ENTERED INTO [REDACTED] VEHICLE AND WAS PROVIDED 2 (TWO) CLEAR BAGS OF POWDER COCAINE WEIGHING +/- 86 GRAMS. THE DEFENDANT WAS ADVISED THAT THE WHITE (STREET TERMINOLOGY FOR COCAINE) WAS A LITTLE MORE THAN 2 (TWO) OUNCES. [REDACTED] THE DEFENDANT DISCUSSED FUTURE NARCOTICS TRANSACTIONS TO BE SMUGGLED INTO THE FLORIDA STATE PRISON FACILITY. WHILE SPEAKING WITH THE DEFENDANT SHE REMINDED THIS DETECTIVE THAT SHE WAS SUPPOSED TO RECEIVE \$500.00 OF U.S. CURRENCY WITH THE UNDERSTANDING THAT IT WAS FOR COMPENSATION IN EXCHANGE FOR THE INTRODUCTION OF THE COCAINE INTO A FLORIDA STATE PRISON FACILITY. THE DEFENDANT WAS THEN PROVIDED THE \$500.00 OF AUTHORIZED FUNDS. THE DEFENDANT VERIFIED THAT SHE WOULD HAVE NO ISSUES ENTERING THE NARCOTICS INTO THE FLORIDA STATE PRISON FACILITY. WHEN ASKED IF THE \$500.00 WAS GOING TO HER, SHE STATED THAT \$500.00 WAS HERS ONLY. THE DEFENDANT PLACED BOTH THE NARCOTICS AND THE CURRENCY INTO HER RIGHT CARGO PANTS POCKET. ONCE THE TRANSACTION WAS CONCLUDED AND THE DEFENDANT EXITED THE VEHICLE, THE DEFENDANT WAS TAKEN INTO CUSTODY WITHOUT INCIDENT. AT THE CONCLUSION [REDACTED], DETECTIVE A. ESTEVEZ RETRIEVED THE CURRENCY AND THE NARCOTICS FROM THE DEFENDANTS RIGHT CARGO PANTS POCKET.
