

84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Inspector Jerry Basford of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe between April 2017 and February 2018, Correctional Officer Addie Amanda King (CO King) in the County of Jackson and the State of Florida, did commit the criminal offense of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47 (1)(a)(1) Fla. Stat., when CO King did actually and intentionally transmit digitally written and recorded communications and digitally transmitted images and video into the secure perimeter of a State Correctional Institution to Inmate Stardale Owens, DC# 195504. Furthermore, CO King did commit the criminal offense of Unlawful Use of a Two-way Communications Device in violation of s. 934.215 Fla. Stat., when CO King did actually and intentionally utilize a cellular telephone to transmit digitally written and recorded communications and digitally transmitted images and video to Inmate Owens while Inmate Owens was housed within the secure perimeter of a State Correctional Institution.

In April 2017, a cellular device was recovered from Inmate Owens at Jackson Correctional Institution. A review of the contents of the cellular device revealed text messaging between Inmate Owens and [REDACTED] the confirmed personal cellular telephone number for CO King. Also noted in the device was communication with Facebook profile, "Cottonmouth Owens," and Facebook profile, "Skylar Gray." Included in the communication between "Cottonmouth Owens" and "Skylar Gray," is an exchange of digital images and video chats; however, the content of the images and video is no longer visible on the device. Based on the context of the communication and the content of the messages "Cottonmouth Owens" and "Skylar Gray," Cottonmouth Owens is Inmate Stardale Owens and Skylar Gray is an alias name and profile used by CO King. The text messages exchanged between Inmate Owens and CO King indicate the images and video exchanged are of a sexual nature. Text message conversation also indicate CO King provided Inmate Owens with a cellular telephone.

In July 2017, Inmate Owens was transferred to Blackwater River Correctional Facility.

In February 2018, a cellular telephone was seized from Inmate Owens at Blackwater River Correctional Facility. The content of the cellular telephone included communication between Inmate Owens and CO King, including text messages and Facebook messages. In addition to the digitally written and transmitted communications, numerous digital images of CO King were noted. Of the images, several clothed and unclothed images of CO King were noted, "Selfie" images of CO King trying on clothes in a department store dressing room, and "screenshot" images of CO King saved by Inmate Owens during sexually based video chat/call sessions. Two screenshot images of Inmate Owens and CO King of particular interest were noted. Based on the appearance of the images, they were taken during a video call/chat. The first image is of CO King clothed in a correctional officer's uniform and seated in what appears to be a Ford Expedition utilized as perimeter vehicle at Jackson Correctional Institution. Due to the time the screenshot was captured, CO King's clothing, and the images background, CO King engaged in a video chat/call with Inmate Owens while she was on duty. The configuration of the image indicates Inmate Owens captured the image. A second image was noted of Inmate Owens unclothed and masturbating. CO King is seen in the upper left of the screenshot indicating the image was obtained during a video chat/call. Based on the configuration, CO King would have captured the image and sent the image to Inmate Owens. The background of the image of CO King is the same sun visor and headliner of a Ford Expedition and includes a State issued walkie-talkie clipped to the sun visor.

Your Affiant respectfully submits probable cause has been established that CORRECTIONAL OFFICER ADDIE AMANDA KING did commit the criminal violation of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47 (1) (a) (1) Florida Statute, when CO KING did actually and intentionally transmit digitally written and recorded communications and digitally transmitted images and video into the secure perimeter of a State Correctional Institution to Inmate Stardale Owens. Your Affiant, further submits probable cause has been established that CO KING did commit the criminal violation of Unlawful Use of a Two-Way Communications Device, in violation of s. 934.215 Florida Statute when CO KING did actually and intentionally utilize a cellular telephone to transmit digitally written and recorded communications and digitally transmitted images and video to Inmate Owens while Inmate Owens was housed within the secure perimeter of a State Correctional Institution.
