The Undersigned Certifies and swears that he has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:

AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Law Enforcement Inspector Ryan Muse with the Office of Inspector General - DC.

On October 14, 2018, at Liberty Correctional Institution (LCI) in Bristol, Florida, the above-named defendant; Correctional Officer Trainee Curtis Chandler, knowingly and with intent committed the criminal offense(s) of:

- Unlawful compensation or reward for official behavior when Officer Chandler accepted monies transmitted electronically via money transfer by means of the "CashApp" cellular phone application from Inmate Keonte Wilson, DC# H36940, in the amount of: \$300.00.

- Unlawfully introduced 4 packages of cigars into LCI to give to Inmate Wilson.

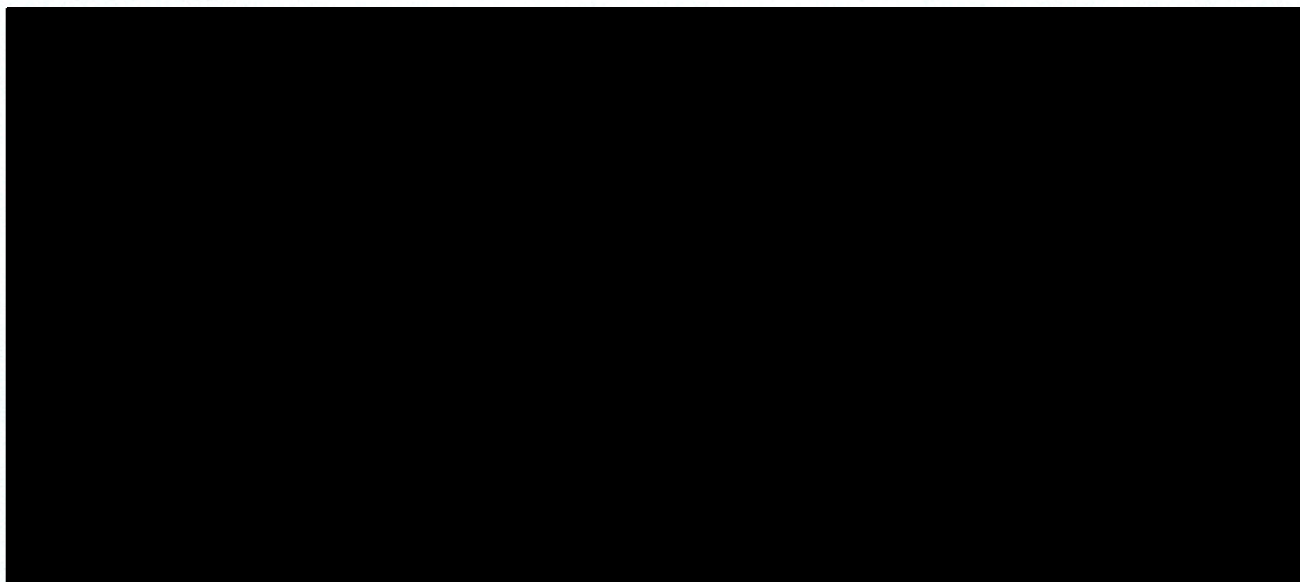
Inspector Muse arrived at LCI at 8:40 AM making contact with Warden Robert Connor who advised him Officer Chandler had arrived at work, entered the Institution, couldn't clear the metal detector, and admitted to security staff members Captain Robert Hover and Sergeant Joseph Jamison he had contraband cigarettes on his person, with 2 more pack hidden inside his underwear. Officer Chandler

made the utterance, "I'm caught, I have cigarettes". Officer Chandler advised security staff that the cigarettes were to be given to inmates.

Note: Officer Chandler stated he was a non-smoker.

All incident reports, submitted Management Information System (MINS) Reports, Chain of Custody Forms, and video evidence were compiled and/or photocopied and given to Inspector Muse. The four initial found packs of cigarettes (actually "Trend" brand cigars) found were stored in the institution's temporary storage locker (TSL), to be picked up later by Evidence Custodian Inspector Randy Henderson.

In his sworn digitally recorded post-Miranda interview conducted at LCI by Inspector Muse on October 14, 2018, at 9:31 AM, Officer Chandler testified to the following:



A search of Officer Chandler's vehicle (a gold Chevrolet Cruze displaying Alabama tag number (0CS45) was conducted with Officer Chandler and two security staff member as witnesses. A black Samsung smart phone, six additional packs of cigarettes, an empty carton box, the piece of paper with "ROD and telephone number (407)858-8109, and a receipt for two packs of cigarettes were located inside the vehicle. The items were photographed in place prior to removal. Officer Chandler signed a Chain of Custody form listing his cell phone which will be turned over the "Guarded Exchange" Forensic Cellular Phone Lab located in Tallahassee Florida on October 15, 2018 for further analysis.

On October 16, 2018, Guarded exchange finalized their report (Report #GEXFL-2018-4588-CurtisHnadler) finding collective DTA stating: "CHANDLER- I have a carton and will bring it on my next shift". Images within the phone show Inmate Ivory Carrington, DC# X64154, with photo of Inmate's CashApp.

Your affiant respectfully submits, probable cause has been established in that, Curtis Chandler committed the criminal violations of Florida State Statutes: Unlawful Compensation or Reward for Official Behavior, in violation of §838.016(1), Introduction of Contraband into a Correctional Facility, in violation of §944.47, in Bristol, Florida.
