On November 27, 2018, at Jefferson Correctional Institution (JCI) in Monticello, Florida, the above-named defendant; Trinity Food Service employee Genna Defaye Alexander, knowingly and with intent, committed the criminal offense of:

Unlawfully introduced of 4 opened packages of cigar style cigarettes into JCI to be delivered to Inmate Darius J. Bee, DC# N12276.

On November 27, 2018 at 9:56 AM, Captain Kristopher Wilson called Inspector Muse advising him of Ms. Alexander arriving for work and entering JCI unable to clear the metal detector. After not being able to clear the metal detector, Ms. Alexander admitted to Officer Sharla Parker and Sergeant Donna Dixon; she had contraband cigarettes on her person, hidden inside her bra. Ms. Alexander advised security staff, the cigarettes were being delivered to Inmate Bee.

Note: Mrs. Alexander stated she was a smoker and only smoked "Newport" brand menthol cigarettes. Ms. Alexander had one unopened pack of Newport Menthol cigarettes in her possession when she entered JCI. A Chain of Custody Forms and video evidence were compiled and/or photocopied and given to Inspector Muse. The four open packs of cigarettes, "305 gold" brand cigar style cigarettes in a zip-lock style sandwich bag, were seized and will be stored in the temporary storage locker (TSL).

In her sworn digitally recorded post- Miranda interview conducted at JCI by Inspectors Muse and James Padgett on November 27, 2018, at 10:15 AM, Mrs. Alexander testified to the following:
