NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE; The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Monte Tatum with the Florida Department of Corrections, Office of the Inspector General. Your Affiant has probable cause to believe and does believe on December 4, 2018, at Santa Rosa Correctional Institution - Work Camp, 5850 E. Milton Road, Milton, Santa Rosa County, Florida, Correctional Officer Lianne A. Portillo, a Correctional Officer with the Florida Department of Corrections, did commit the criminal offense of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47(1)(a)4 Fla. Stat., when Officer Portillo did actually and intentionally introduce a Controlled Substance, (Suboxone), onto the grounds of a State Correctional Institution; Further, Officer Portillo did commit the criminal offense of Possession a Controlled Substance, in violation of s. 893.13(1)(a)2 Fla. Stat., without a prescription.

On December 4, 2018, Correctional Officer Captain Daren Lawson utilized his K9, Taco - a certified narcotic canine, during a free air sniff as Officer Portillo entered Santa Rosa Correctional Institution - Work Camp visitation area. This is located within the secured perimeter of the State Correctional Institution. K9 Taco indicated a positive alert to the odor of narcotics emanating from the person of Officer Portillo. Officer Portillo was then subjected to a pat search by female security staff with no contraband recovered.

After providing a voluntary, signed consent to search, Officer Portillo's vehicle, a 2015, Honda Civic, bearing Florida Tag JFKR55, registered to Officer Portillo, was searched by Captain Lawson. During this search, an opened, Suboxone, 8mg/2mg, (Buprenorphine and naloxone), sublingual strip, a Schedule V controlled substance, was found in the center console.

During a Post-Miranda statement, obtained by your Affiant, Officer Portillo stated she denied knowledge of the Suboxone in her vehicle and denied the substance was hers.

Your Affiant respectfully submits probable cause has been established to conclude Correctional Officer Lianne A. Portillo did commit the criminal violation of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47(1)(a)4 Florida Statute, and s. 893.13(1)(a)2, Florida Statute, when Officer Portillo did actually and intentionally possess a Controlled Substance, Suboxone, a schedule V Controlled Substance
