84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant Inspector Erika Ridley of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe Joli Cheyenne Ladd, a certified correctional officer at Northwest Florida Reception Center, did commit the criminal offense of Introduction of Contraband into a state institution, to wit cigarettes in violation of FS 944.47 3 counts and Unlawful Compensation or Reward for Official Behavior in violation of FS 838.016 3 counts by accepting financial compensation, \$700 for introducing the contraband into the secure portion of the institution in violation of state statute.

Intelligence gathered through internal Department of Corrections data bases indicated Officer Ladd had been communicating with Inmate Anthony Guarino DC #L90048 electronically through text messaging and voice. These communications were through Officer Ladd's email address and the recorded Department of Corrections elephones. Officer Ladd included pictures of herself and her child in the text communications. In these communications Officer Ladd and Inmate Guarino openly discussed contraband and Officer Ladd's compensation. On December 10, 2018, in a telephone conversation Officer Ladd and inmate Guarino spoke about introducing what was believed to be cellular telephones into the secure portion of the facility on December 11, 2018 when Officer Ladd was scheduled to work.

On December 11, 2018, when Officer Ladd arrived at NWFRC Annex and entered the secure point of the institution Warden Michael Mashburn had an in depth pat search performed on Officer Ladd and Officer Ladd consented to a vehicle search by the Interdiction Unit. No contraband was found on Officer Ladd's person. During the search of Officer Ladd's vehicle, multiple new cellular telephone chargers were discovered along with electrical tape and cigarette butts which had been torn off. The electrical tape and cigarette butts are indications of contraband introduction.

In a post Miranda interview, Officer Ladd	
In telephone conversations between Officer Ladd and Inmate Guarino, the name "Q	uarter" was mentioned on several

occasions.

In a sworn interview Officer Jeremy Faison, who was involved in a personal relationship with Officer Ladd, indicated the found individually packaged cigarettes and two SIM cards wrapped in a way consistent with introduction inside

Officer Ladd's house. When asked, Officer Ladd indicated she had thought about introducing the contraband but had changed her mind. Officer Faison reported the incident.

In a sworn interview, Captain Martin indicated he reviewed a video of Officer Ladd removing something from her clothing and placing it on a shelf in food service inside the RDP cage. Captain Martin stated that inmates were in and out of the area but did not appear to have tampered with the area where Officer Ladd was. Later in the Day, Sergeant Askew discovered two cell phones where Officer Ladd placed the items she removed from her clothing. The video was copied to a disc but misplaced.

A review of Officer Ladd's financial records from Western Union showed Officer Ladd received a payment of \$200 USD from Princshadra Wood on September 21, 2018. Ms. Wood is an approved visitor for Inmate Melvin Williams, DC #P37430, previously discussed in telephone conversations as "Quarter".

In a sworn interview with Inmate Melvin Williams indicated Officer Ladd had brought Inmate Williams cigarettes on two different occasions. Inmate Williams met Officer Ladd through Inmate Guarino. Officer Ladd brought Inmate Williams two cartons of cigarettes, totaling 20 packs of cigarettes. Princshadra Wood is Inmate Williams' girlfriend and Ms. Wood paid Officer Ladd \$200 USD for the two cartons of cigarettes. Inmate Williams indicated Officer Ladd had the cigarettes "bombed up" which meant that she had them packaged and taped up. When Officer Ladd brought the cigarettes, she would bring them to Inmate Williams in N dormitory, where he was housed.

Your Affiant respectfully submits that probable cause has been established that Joli Cheyenne Ladd did commit the criminal violation of introduction of contraband into a state institution to wit, cigarettes in violation of 944.47, Fla. Stat. 3 counts, and Unlawful Compensation or Reward for Official Behavior in violation of 8383.016 Fla Stat. 3 counts, by receiving financial compensation for introducing contraband into the secure portion of Northwest Florida Reception center (NWFRC). It is requested a warrant be issued for Joli Cheyenne Ladd's arrest for violation of state statutes pertaining to the introduction of controlled substances into a state correctional institution and unlawful compensation.
