Your Affiant is Senior Inspector Mai Morris with the Florida Department of Corrections (FDC), Office of the Inspector General (OIG), Special Investigations Unit (SIU).

Your Affiant has probable cause to believe that on October 30, 2018, Michael Collins, a FDC, OIG Inspector assigned to Wakulla Correctional Institution, did violate Florida State Statute 837.012, Perjury when Not in an Official Proceeding, when he made a false statement, which he believed was untrue, under oath, not in an official proceeding, regarding any material matter to wit:

On October 30, 2018, FDC, OIG, SIU Senior Inspector Roger Murphy conducted a sworn, recorded interview of Inspector Collins at the Wakulla Correctional Institution, located in Wakulla County, Florida. Present during this interview was FDC, OIG, SIU Senior Inspector Allyson Skiles. During this interview, Inspector Collins repeatedly denied that on August 21, 2018, he went to the residence [REDACTED] of [REDACTED], a witness in a FDC OIG complaint review to which he was the primary assigned inspector. Inspector Collins further denied, at any time, having physically contacted [REDACTED] at any location outside the Wakulla County Animal Shelter.

On January 16, 2019, Inspector Morris contacted Inspector Collins to arrange for him to be re-interviewed [REDACTED]. On January 25, 2019, Inspector Morris [REDACTED] he had, in fact, gone to [REDACTED] residence.

It should be noted that from October 30, 2018 to the present, Inspector Collins had made no attempts to contact Inspector Murphy to correct his prior statement and/or to notify him that he recalled having, in fact, gone to [REDACTED] residence.

Based upon the aforementioned facts, Inspector Morris believes there is sufficient probable cause to support Inspector Collins did violate Florida State Statute 837.012, Perjury when Not in an Official Proceeding.

This incident occurred in Wakulla County, Florida.
