### **Local Burglary Suspect Runs Out of Gas**

On January 4, 2019, the Leon County Sheriff's Office responded to a burglary alarm at 553 Capital Circle SW (City Electric Supply). Upon arriving in the area, deputies saw 34 year old **William Whitaker** using a rock to break the glass on the front door of the business. Before deputies could stop Whitaker, he got into his vehicle, a white Nissan, and quickly drove off. Deputies attempted a traffic stop but Whitaker refused to stop. A short distance later, the vehicle ran out of gas and the vehicle stopped. Whitaker was then taken into custody by deputies.

Through the follow up investigation, by TPD Investigators and LCSO Detectives established, probable cause to charge Whitaker with the following incidents:

On January 2, 2019, the Tallahassee Police Department responded to 1467 Capital Circle NW (Buddy's Home Furniture) due to a glass break alarm. A burglary was discovered with the point of entry being a shattered glass front door. The business reported a home theater system as being stolen and a review of the surveillance footage provided a suspect description of a light skinned black male with tattoos on both arms and a tattoo on the top of his left hand. The surveillance footage also captured the suspect leaving in a white sedan.

On the same date, the Leon County Sheriff's Office responded to a burglary alarm at 870 Blountstown St. (Leon County Tax Collectors Office). A shattered glass door was discovered with a television reported stolen. Surveillance footage captured the same suspect who burglarized Buddy's Home Furniture.

On January 3, 2019, the Tallahassee Police Department again responded to 1467 Capital Circle NW (Buddy's Home Furniture) due to a glass break alarm. A second burglary was discovered with nothing reported stolen. A review of the surveillance footage showed the same suspect from the previous burglary along with the same vehicle. TPD also responded to 3613 Crawfordville Rd (Family Dollar) for a burglary alarm. The suspect smashed the front window to the business and stole several packs of cigarettes.

Whitaker was later taken to the Leon County Detention Facility for booking with pending charges.
