

WARRANT

TO EACH SHERIFF OF THE STATE OF FLORIDA:

WHEREAS, a Sworn Complaint, having been this day filed before me as Judge of the Circuit Court in and for Jackson County, wherein it is alleged that:

COUNT I: HOLLY ANN HAESSIG, between February 1, 2016 and December 31, 2018, in the County of Jackson and State of Florida, while a public servant, did corruptly request, solicit, accept, or agree to accept, any benefit not authorized by law, for the past, present, or future performance, nonperformance, or violation of any act or omission which Holly Ann Haessig, a public servant, represented as having been, either within her official discretion, in violation of a public duty, or in performance of a public duty, contrary to Florida Statute 838.016. (F2-L7)

COUNT II: HOLLY ANN HAESSIG, between February 1, 2016 and December 31, 2018, in the County of Jackson and State of Florida, while a public servant, did corruptly request, solicit, accept, or agree to accept, any benefit not authorized by law, for the past, present, or future performance, nonperformance, or violation of any act or omission which Holly Ann Haessig, a public servant,

(F3-L3)

COUNT XXII: HOLLY ANN HAESSIG, between February 1, 2016 and December 31, 2018, in the County of Jackson and State of Florida, did unlawfully introduce into or upon the grounds of a state correctional institution, food and/or clothing, or take or attempt to take or send or attempt to send therefrom, food and/or clothing, a contraband article, contrary to Florida Statute 944.47. (F3-L3)

COUNT XXIII: HOLLY ANN HAESSIG, between February 1, 2016 and December 31, 2018, in the County of Jackson and State of Florida, did, without authority, interfere with or in any way interrupt the work of any prisoner under the custody of the Department of Corrections or did in any way interfere with the discipline or good conduct of any prisoner, contrary to Florida Statute 944.39. (M2-LM)

COUNT XXIV: HOLLY ANN HAESSIG, between February 1, 2016 and December 31, 2018, in the County of Jackson and State of Florida, did unlawfully use a two-way communications device, including, but not limited to, a portable two-way wireless communications device, to facilitate or further the commission of a felony offense, contrary to Florida Statute 934.215. (F3-L4)

THERFORE, you are hereby commanded to arrest instanter the said HOLLY ANN HAESSIG.
