Narrative: Your Affiant is Senior Inspector Justin Bates with the Office of Inspector General for the Florida Department of Corrections, Special Investigations Unit;

On or about September 8, 2018, the defendant above, a sworn Correctional Officer with the Florida Department of Corrections assigned at Sumpter Correctional Institution became the subject of an investigation involving introduction of contraband and unlawful compensation. Information was provided to your affiant from a forensic cellular phone download and inmate sources, indicating the defendant would introduce contraband into the grounds of Sumpter Correctional Institution for payment via money wire transfers.

On October 30, 2018, your affiant utilized a subpoena to obtain records from Western Union. A short time later, Western Union returned the subpoena with records showing the defendant received two wire transfers from an Andy Martinez and Mike Shine, both family members of inmates who were housed at Sumpter Correctional Institution at the time of the transactions. In total the defendant received \$150.00 in illegal wire transfers for the alleged introduction of cigarettes.

On October 30, 2018, your affiant utilized a subpoena to obtain records from Ria Financial Services. A short time later, RIA returned the subpoena with records showing the defendant received three wire transfers from family members of inmates who were housed at Sumpter Correctional Institution Two of the transactions were from Francisca Izquierdo and the other from Ada Medina. In total the defendant received \$360.00 in illegal wire transfers for the alleged introduction of cigarettes.

On February 11, 2019, your affiant spoke with the defendant post miranda and the defendant
