84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Erika Ridley with the Florida Department of Corrections, Office of the Inspector General. Your Affiant has probable cause to believe that between June 04, 2019 and June 05, 2019, at Northwest Florida Reception Center, 4455 Sam Mitchell Dr. Chipley, Florida, Correctional Officer Kallie Powell, a Correctional Officer (CO) with the Florida Department of Corrections, did commit the criminal offense of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47(1)(a)(1) Fla. Stat., when CO Powell did actually and intentionally transmit digitally written and recorded communications into the secure perimeter of a State Correctional Institution to Inmate Ryan Giles DC# R62265; and CO Powell did actually and intentionally utilize a cellular telephone to transmit digitally written and recorded communications to Inmate Bauer while Inmate Giles was housed within the secure perimeter of a State Correctional Institution.

On June 05, 2019, The Florida Department of Corrections, Office of the Inspector General received information from Security Threat Group (STG) Sergeant, Sergeant Tanner Sketo, a Correctional Officer Sergeant with the Florida Department Of Corrections, which indicated the possibility of a staff member communicating with Inmate Ryan Giles via Jpay, an email application used by inmates to communicate with outside civilians and family members. Upon further review, Your Affiant was able to determine that a fictitious Jpay account had been created in order to communicate with Inmate Giles. The Jpay account had the listed name of Keri Smith, an address of 6313 Quail Ridge Drive, Tampa Florida, a phone number of 850-336-8521, and an email address of Kalliepowell22@gmail.com. Your affiant was able to establish that this account was created by CO Powell due to the email address listed on the account matching the email address CO Powell provided to the Department of Corrections on her supplemental application. Furthermore, CO Powell stated in an email on June 04, 2019, that she had to shoot the shotgun. On June 04, 2019, CO Powell attended DART training, where she fired the shotgun,

CO Powell sent a total of five messages to Inmate Giles using the fictitious Jpay account and received a total of nine messages from Inmate Giles.

In a message dated June 04, 2019 at approximately 2:48 pm CST, CO Powell stated "Heyyy Papi!!!! I just got off. We had to shoot the shotgun. I wish I could have talked to you longer. I like it when I get to hear your voice. You know I want you to be truthful with me. If this is just business I need to know just so I don't get my feelings involved"

In a message dated June 05, 2019 at approximately 9:43pm CST, CO Powell stated "Well today was a little stressful day lol. How are ya? I'm hoping to hear from you soon. I need to hear from you. Maybe I'll feel better once I do. By the way, I love Mexican food!!!! I love all food lol because I love to eat period. It's like one of my hobbies hahaha but the key to my heart is Mexican. I could eat it all day every day. Me an you both have something in common. Our bdays is but like years an months apart. I pretty much spend all my time with my little girl. We will go shopping or swimming. Play the game, mostly shooting games cuz im a killa lol. And let's not forget napping. I'm a nap Queen. I love to cook but hate, hate to wash dishes. Let me remind you I hate washing dishes. I just don't like to have to cook an wash dishes. I'll do one or the other tho. I really wish I could hear your voice right now. Have a good day at work, XOXOXO"

It should be noted that Inmate Giles date of birth is July 29, 1991 and CO Powell's date of birth is It should also be noted that on June 5, 2019 CO Powell was at work at Northwest Florida Reception Center assigned to perimeter from the hours of 6:00PM CST to June 6, 2019 at 6:00am.

In an incident report dated June 6, 2019 CO Powell stated "On 6-6-19, I was assigned as Roving Post 3 Officer. I was searched leaving off duty. I had my phone, phone charger, and apple watch on my [person. As I was assigned to roving officer, I retrieved my phone and phone charger from my car. As assigned as the roving officer, I used my phone to play games and listen to music throughout the night." Powell was in direct violation of Department Policy 602.016 (5) (j) which states, "except as authorized in section (5)(d),(f),(g), and 9h0 of this procedure, cell phones are prohibited from being introduced or possessed by: (2) "on-duty staff who's assigned duties are outside the security perimeter of an institution." CO Powell is also in direct violation of Florida Administrative Code 33-208.002 (26), which states "Employees shall maintain a professional relationship with all persons in the custody or under supervision of the Department and their immediate family or visitors. No personal or business relationships are permitted. Marriage between employees and inmates is not permitted."

The email from CO Powell dated June 5, 2019 at approximately 9:43pm CST was sent from IP address 174.223.136.113 as were emails sent by CO Powell dated June 5, 2019 at approximately 09:20 am CST and June 04, 2019 at approximately 2:48 pm CST. Your affiant has probable cause to believe that CO Powell used her cellular phone on at least three occasions to transmit digitally written communications to Inmate Giles via Jpay and digitally transmitted written communications to Inmate Giles via Jpay on two other occasions. Jpay communications is not an authorized channel of communication between inmates and staff.

Your Affiant respectfully submits probable cause has been established to conclude Correctional Officer Kallie Deborah Marie Powell did commit the criminal violation of Introduction of Contraband into a State Correctional Institution, in violation of s. 944.47(1)(a)(1) Florida Statute, when CO Powell did actually and intentionally transmit digitally written communications into the secure perimeter of a State Correctional Institution to Inmate Ryan Giles on 5 occasions. Your Affiant further submits probably cause has been established CO Powell did commit the criminal violation of Unlawful Use of a Two-Way Communications Device, in violation of s. 934.215 Florida Statute when CO Powell did actually and intentionally utilize a cellular telephone to transmit digitally written communications to Inmate Bauer while Inmate Giles was housed within the secure perimeter of a State Correctional Institution on three occasions.
