84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant, Senior Inspector Christopher Baty, is a sworn law enforcement officer of the Office of the Inspector General, Florida Department of Corrections.

On June 6, 2019, at Desoto Correctional Institution Annex, Desoto, Florida, Desoto County, the above-named defendant, Correctional Officer Vanica Clermond [REDACTED] did violate Florida State Statutes, committing the criminal offenses of: Introduction and possession of unlawful articles in a correctional facility; by knowingly and intentionally introduced Suboxone strips into Desoto Correctional Institution (1 Count), (F.S.S. 944.47(1)(a)(1) and (1 Count) 893.03. The defendant, Clermond had in her possession two bundles with Suboxone strip hidden inside white dental power to be delivered to an inmate within Desoto Correctional Institution Annex(C.I.), where Clermond is employed. At the time of the discovery, Officer Clermond had entered the correctional facility for work duty.

944.47 Introduction, removal, or possession of certain articles unlawful; penalty.—

(1)(a) Except through regular channels as authorized by the officer in charge of the correctional institution, it is unlawful to introduce into or upon the grounds of any state correctional institution, or to take or attempt to take or send or attempt to send therefrom, any of the following articles which are hereby declared to be contraband for the purposes of this section, to wit:

3. Any intoxicating beverage or beverage which causes or may cause an intoxicating effect.

893.03 Possession of narcotics—

(The substances enumerated in this section are controlled by this chapter. The controlled substances listed or to be listed in Schedules I, II, III, IV, and V are included by whatever official, common, usual, chemical, trade name, or class designated. The provisions of this section shall not be construed to include within any of the schedules contained in this section any excluded drugs listed within the purview of 21 C.F.R. s. 1308.22, styled "Excluded Substances"; 21 C.F.R. s. 1308.24, styled "Exempt Chemical Preparations"; 21 C.F.R. s. 1308.32, styled "Exempted Prescription Products"; or 21 C.F.R. s. 1308.34, styled "Exempt Anabolic Steroid Products".

Correctional Officer Vancia Clermond provided a sworn statement post Miranda: [REDACTED]

In summary, the defendant, Vancia Clermond, did knowingly and intentionally introduce the contraband into Charlotte Correctional Institution within Desoto Correctional Institution Annex, violating 1 count of Florida State Statute 944.47 (1)(a)(3) Introduction and possession of unlawful articles, and 893.03 possession of Narcotics.


