Your affiant is Law Enforcement Inspector Joseph Varnum with the Office of Inspector General – FDC.

Your affiant has probable cause to believe, Florida Department of Corrections (FDC) Correctional Officer Janetta Lynne Jones, who works at Liberty Correctional Institution (LCI), violated §944.47(1)(a)(1), when between April 10, 2019 and May 31, 2019, Jones had a fraudulent JPay account setup using the name Unique Daniels and sent emails (*written communication*) and explicit pictures to Inmate Corey Daniels DC# M47436.

On May 31, 2019, your affiant conducted a sworn post Miranda interview with Officer Jones, [REDACTED]

On June 05, 2019, your affiant conducted a sworn interview with Ms. Tammy Brown, she indicated she was contacted by Officer Jones wanting her to setup a JPay account under the false name of “Unique Daniels” in mid-April, so she could communicate with Inmate Daniels. Ms. Brown indicated Officer Jones would put money in her bank account for her to deposit it into Inmate Daniels JPay account. JPay records show 4 transactions totaling \$375.00 dollars. Ms. Brown stated Officer Jones needed her to do it because it would not look good if an Officer was found talking to an inmate. Ms. Brown also showed me her cash app, where funds in the amount of \$100.00 dollars were sent three different times to her for Officer Jones. Ms. Brown stated Officer Jones told her Inmate Daniels is trying to show he can take care of her, even though he is in prison.

Your affiant respectfully submits, probable cause has been established, in that, Officer Janetta Lynne Jones, B/F, DOB: [REDACTED], committed the criminal violation of Introduction, removal, or possession of certain articles unlawful, in violation of §944.47(1)(a)(1), Fla. Stat., in Bristol, Florida. Your affiant respectfully requests an arrest warrant be issued

for: Janetta Lynne Jones for 1 count of §944.47(1)(a)(1), for the laws relating to Introduction, removal, or possession of certain articles unlawful.
