NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the 17 of July 2019 at 10:17 at 158 EAST LANDSTREET ROAD, ORLANDO, FLORIDA (Zone: District 7) in Orange County did

The Defendant is employed by the State of Florida, Department of Corrections, as a Vocational Instructor. The Defendant is responsible for overseeing the daily operations of the vehicle repair facility (Motor Pool) at the Central Florida Reception Center.

The Defendant is the subject of an on-going investigation by the Office of the Inspector General related to theft of State Owned Property.

On July 17, 2019, Inspector Z. Mulharan received information that three new tires, purchased by the State of Florida for use on Department of Corrections Vehicles, had been loaded into State Vehicle #9484. Inspector Mulharan observed the Defendant driving Vehicle #9484 (containing the tires) off of State Property. Inspector Mulharan followed the Defendant to Auto Parts of Taft (158 Landstreet Road, Orlando, Florida) where he observed the Defendant unloading the three new tires, placing them inside of the business. Upon the Defendant leaving the business Inspector Mulharan made contact with the Owner of Auto Parts of Taft (Russell Thompson). Thompson stated that his business is an authorized vendor for the State of Florida and he routinely conducts business with the Defendant. Thompson states that on July 17, 2019, the Defendant came to his business and placed several tires into the storage area. Thompson showed Inspector Mulharan the tires that the Defendant had just dropped off. Upon inspection it was determined that the tires were still marked with letters "CFR" indicating that they belong to Central Florida Reception Center, the manufacturing stickers were still affixed to the tires. Inspector Mulharan and Agents of the Florida Department of Law Enforcement seized the tires as evidence. Thompson states that the Defendant routinely, for the past 2 to 3 years, brings tires and auto parts to his business, in a State Vehicle, for storage. Thompson further states that the Defendant will return to the business after 3:00 PM in his personal vehicle (described by Thompson as a Toyota Tundra) to recover the auto parts / tires that he previously stored at the business. Thompson states that he believed that the Defendant was stealing property from the State but did not want to report the Defendants actions for fear of losing State Business. The total value of the Tires that the Defendant unlawfully deprived the State of Florida of is \$1,050.00.

On July 17, 2019, the Defendant did unlawfully and without authorization remove \$1,050.00 worth of tires, owned by the State of Florida, from State of Florida Property with the intent to temporarily or permanently deprive the owner of a right to the property or a benefit from the property.
