HAVING RECEIVED AND CONSIDERED THE SWORN AFFIDAVIT OF SENIOR INSPECTOR CHESTER POTTER, DATED THE DAY OF, 8th AUGUST 2019, SAID AFFIDAVIT ALLEGING:

COUNT 1: Introduction of Contraband

That Orean Dorminey, a former Correctional Officer at Hamilton Correctional Institution, on or between September 2018 and May 2019, did then and there unlawfully contraband in the form of written or recorded transmissions via text messages, phone calls, written and recorded electronic transmissions (emails or messages), as well as Jpay email messages under a fictitious name, into the secure perimeter of Hamilton Correctional Institution and to an inmate of Hamilton Correctional Institute contrary to Florida Statute 944.47(1)(a).


COUNT 2: Unlawful use of a two-way communication device

That Orean Dorminey, a former Correctional Officer at Hamilton Correctional Institution, between September 2018 and May 2019, did then and there unlawfully utilize a cellular telephone to facilitate the introduction of contraband, in the form of text messages and phone calls, written and recorded transmissions, into the secure perimeter of Hamilton Correctional Institution and to an inmate of Hamilton Correctional Institute while she was employed a corrections officer, contrary to Florida Statute 934.215.

AFFIDAVIT FOR ARREST

Before me, Circuit Court Judge Melissa G. Olin, personally appeared Senior Inspector Chester Potter, who being sworn, deposes and says:

COUNT 1: Introduction of Contraband

That Orean Dorminey, a former Correctional Officer at Hamilton Correctional Institution, on or between September 2018 and May 2019, did then and there unlawfully introduce contraband in the form of written or recorded transmissions via text messages, phone calls, written and recorded electronic transmissions (emails or messages), as well as Jpay email messages under a fictitious name, into the secure perimeter of Hamilton Correctional Institution and to an inmate of Hamilton Correctional Institute, contrary to Florida Statute 944.47(1)(a).

COUNT 2: Unlawful use of a two-way communication device

That Orean Dorminey, a former Correctional Officer at Hamilton Correctional Institution, between September 2018 and May 2019, did then and there unlawfully utilize a cellular telephone to facilitate the introduction of contraband, in the form of text messages and phone calls, written and recorded transmissions, into the secure perimeter of Hamilton Correctional Institution and to an inmate of Hamilton Correctional Institute while she was employed a corrections officer, contrary to Florida Statute 934.215.


Your affiant has documented his probable cause in a complaint affidavit attached to this document as EXHIBIT A; wherein, the above violations are further explained. Your affiant swears that EXHIBIT A is true.

The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:
 On the 24th day of May 2019 at 1:20 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Senior Inspector Chip Potter with the Office of Inspector General for the Florida Department of Corrections, and the defendant is Former Officer Orea Dorminey (*Officer Dorminey*) who was assigned to Hamilton Correctional Institution (*HCI*). Your affiant has investigated an Introduction of Contraband, and unlawful use of a two-way communication device, in response to Officer Dorminey utilizing a cell phone to communicate with an inmate currently housed within the Florida Department of Corrections.

On May 24, 2019, during a mass search of F-dormitory at HCI Annex, a cellular phone was in the possession of Inmate Omar Ayyash (*Inmate Ayyash*) DC# I41925. Inmate Ayyash was currently utilizing the phone when staff discovered it. When staff seized the phone, a text message came into the phone from a local phone number [REDACTED]. Research on the cell phone number resulted in a link to Officer Dorminey. Further research and screenshots taken from the contraband phone revealed pictures of a young child that was identical to the photos of Officer Dorminey's youngest child which she had posted on her Facebook page.

An extraction of data from Inmate Ayyash's cell phone, documented at least three (3) phone calls made between his phone and Officer Dorminey's cell phone number, to include the text on the night he was caught.


Also located during database searches were approximately 70 Jpay messages sent to and from Inmate Ayyash from a fictitious name, "His Queen" with an address listed for this account as a former address of Officer Dorminey. The messages on Jpay were communicated between September 2018 and December 2018.

Inmate Ayyash was interviewed and confirmed all the Jpay messages between he and "His Queen", were between he and Officer Dorminey. Content in the Jpay messages, coupled with the former address of Officer Dorminey clearly indicates Officer Dorminey established a fictitious name to conceal her identity as a Correctional Officer while she clearly communicated with Inmate Ayyash. Inmate Ayyash admitted during testimony he and Officer Dorminey were in a relationship and the cell phone he was caught with was a way for her to contact him, along with Jpay. Inmate Ayyash admits the photos of the male child on the phone were that of Officer Dorminey's child which she sent to him.

Your affiant spoke with Officer Dorminey on the phone attempting to meet for an interview; however, despite her confirming on the phone her number is the same number listed above, which was discovered on Inmate Ayyash's contraband phone, she would not commit to an interview. A second attempt to contact her met with negative results, her number has been changed or disconnected.

Your Affiant respectfully submits probable cause has been established indicating Officer Dorminey did commit the violation of Introduction of Contraband into a state institution (*electronic transmissions*) in violation of FSS 944.47(1)(a)1 and Unlawful use of a two-way communication device in violation of FSS 934.215 in Hamilton County, Hamilton Correctional Institution on between September 2018 and May 2019. Your Affiant respectfully requests a warrant be issued for Oreaan Dorminey for one count of FSS 944.47(1)(a)1 Introduction of contraband into a state institution (*electronic transmissions*) and one count of 934.215, Unlawful use of a two-way communication device.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
