

BEFORE ME, D. Talun Davis, a Judge of the above captioned court, personally appeared before me Law Enforcement Inspector Supervisor Daniel Gonzalez, who being first duly sworn, deposes and says:

Your Affiant has probable cause to believe that on August 6, 2019, at approximately 5:30 p.m., at the Florida State Prison, in Bradford County, Florida, Education Supervisor Antonio Carlisle did commit the offense of Sexual Battery along with Sexual Misconduct, in violation of Florida Statutes 794.011(4)(b) and 944.35(3)(b)2 respectively, when he, an employee of the Department of Corrections, did actually and intentionally engage in sexual battery and sexual misconduct with an inmate, [REDACTED] inside the secure perimeter of the Florida State Prison.

Senior Inspector Kevin Ortiz of the Florida Department of Corrections Office of the Inspector General responded to FSP on the same date and obtained a sworn recorded statement from Inmate [REDACTED] Inmate [REDACTED] stated that [REDACTED]

Inmate ██████████ ██████████ which took place at FSP on August 7, 2019, at approximately 2:35 a.m. ██████████ ██████████ to Inmate ██████████ A Sexual Assault Kit was collected consisting of buccal swabs, rectum swabs, left torso swab, right torso swab, and underwear. The examination kit was entered into evidence. On August 29, 2019, Evidence Inspector David Manning electronically submitted the evidence information to the Florida Department of Law Enforcement (FDLE) Laboratory; and hand delivered the evidence on August 30, 2019, for testing. On December 3, 2019, a Laboratory Report was prepared by the Florida Department of Law Enforcement which indicated the swabs taken from the rectum and right torso demonstrated the presence of a mixture consistent with two donors including at least one male contributor. ██████████ ██████████ was expected to be a donor. A complete foreign DNA (Deoxyribonucleic Acid) profile consistent with a male contributor was obtained and suitable for comparison. It was requested that buccal swabs from Antonio Carlisle and any other subject(s) be submitted for DNA analysis.

On January 29, 2020, an Application and Affidavit for a Search Warrant was approved in order to obtain saliva and skin cells via oral swab from inside the cheek of Antonio Carlisle for DNA analysis. On January 30, 2020, the search warrant was executed, and on the same date the swabs obtained from Antonio Carlisle were submitted to the FDLE Laboratory for testing.

On February 5, 2020, the FDLE lab report regarding the comparison between the DNA swabs from the Sexual Assault Kit and the swabs obtained from the defendant was obtained by the Office of Inspector General. In the report, FDLE analyst reported a match between the two. The profile obtained from the defendant is greater than 700 billion times more likely to occur if the sample originated from Antonio Carlisle than from an unrelated individual.

Your Affiant respectfully submits that probable cause is established that Antonio Carlisle did commit the offense of Sexual Battery; in violation of Florida Statute 794.011(4)(b); which took place on the grounds of the Florida State Prison in Bradford County, Florida.

Your Affiant respectfully submits that probable cause is established that Antonio Carlisle did commit the offense of Sexual Misconduct; in violation of Florida Statute 944.35(3)(b)2; which took place on the grounds of the Florida State Prison in Bradford County, Florida.

WHEREFORE, your affiant prays that an arrest warrant be issued according to law commanding all and singular the Sheriffs of the State of Florida to forthwith arrest the said Antonio Carlisle and bring him before the court to answer the charge of Sexual Misconduct.
