Your affiant is Senior Inspector Carrie Barcia of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that during the time frame of July 14, 2017 and January 4, 2019, the defendant, Correctional Officer Jeremy Mitchem, formerly employed by the Florida Department of Corrections did commit the criminal offense Unlawful Compensation or Reward for Official Behavior, in violation of § FSS 838.016(1) Florida Statute and Introduction of Contraband into a Secure Facility, in violation of § FSS944.47(1)(b)(2) Florida Statute.

The defendant was assigned to Cross City East Unit from September 9, 2016 until February 8, 2019. The defendant completed the Basic Recruit Correctional Officer Training Program on April 6, 2017.

Inmate Devron Johnson DC No. 970831 was housed at Cross City East Unit from February 24, 2017 to August 18, 2017. Inmate Johnson asked Florida Department of Corrections documented visitor applicant, Ms. Nicole Slocum to send money to the defendant.

On July 14, 2017, Ms. Slocum sent a money wire transfer in the amount of \$500.00 to the defendant using Ria Financial. The defendant picked up the money on the same day from Walmart No.1297, located in Chiefland, Florida.

Inmate Moise Cherette DC No. B06110 was housed at Cross City East Unit from May 12, 2017 to August 31, 2017. During the month of August 2017 audio recorded phone calls between Inmate Cherette and Florida Department of Corrections documented visitor, Joedono "Adrian" Whyte indicate that Ms. Whyte was assisting Inmate Cherette by sending and receiving money through Western Union on his behalf.

On August 1, 2017, Ms. Whyte, sent a money wire transfer in the amount of \$500.00 to the defendant using Western Union. The defendant picked up the money on August 2, 2017 from Winn Dixie No. 0168, located in Chiefland, Fl.

On August 20, 2017, Ms. Whyte sent a money wire transfer in the amount of \$300.00 to the defendant using Western Union. The defendant picked up the money on the same day from Winn Dixie No. 0168, located in Chiefland, Fl.

Inmate Tony Severance DC No. 131296 was housed at Cross City East Unit from April 3, 2015 until May 31, 2018. Inmate Severance made an agreement with the defendant to purchase cigarettes in exchange for money. **Count 12-** Inmate Severance asked Florida Department of Corrections documented visitors, Ms. Shanita Baker and Ms. Otesha Carter to send the defendant money for the cigarettes.

On April 4, 2018, Ms. Baker sent a money wire transfer in the amount of \$200.00 to the defendant using RIA Financial. The defendant picked up the money on the same day from Walmart No.1297, located in Chiefland, Florida.

On April 21, 2018, Ms. Baker sent a money wire transfer in the amount of \$200.00 to the defendant using RIA Financial. The defendant picked up the money on the same day from Walmart No.1297, located in Chiefland, Florida.

On April 30, 2018, Ms. Baker sent a money wire transfer in the amount of \$250.00 to the defendant using RIA Financial. The defendant picked up the money on the same day from Walmart No.1297, located in Chiefland, Florida.

On May 26, 2018, a friend of Inmate Severance, Otesha Carter, sent a money wire transfer in the amount of \$500.00 to the defendant using Western Union. The defendant picked up the money on May 27, 2018 from Winn Dixie No. 0168, located in Chiefland, Fl.

Inmate Kentrail McRae DC No. R45317 was housed at Cross City East Unit from January 5, 2018 to August 28, 2018 and then again from September 19, 2018 to November 8, 2018. Inmate McCrae made an agreement with the defendant to purchase cigarettes **Count 13-** in exchange for money. Inmate McRae asked Florida Department of Corrections documented visitors, Kendra McRae and Tracy McRae to send the defendant money.

On July 3, 2018, Ms. Kendra McRae sent a money wire transfer in the amount of \$400.00 to the defendant using RIA Financial. The defendant picked up the money on the same day from Walmart No.1297, located in Chiefland, Florida.

On August 12, 2018, Ms. Tracy McRae sent a money wire transfer in the amount of \$300.00 to the defendant using RIA Financial. The defendant picked up the money on August 14, 2018 from Walmart No.1297, located in Chiefland, Florida.

On October 7, 2018, Ms. Tracey McRae sent a money wire transfer in the amount of \$292.00 to the defendant using RIA Financial. The defendant picked up the money on October 8, 2018 from Walmart No.1297, located in Chiefland, Florida. Once the money had been received, the defendant brought the cigarettes to Inmate McRae by packaging the cigarettes in a plastic Ziploc bag and dropping them on the floor of the inmate bathroom to be picked up. Inmate Patrick Lee DC No. 816952 was housed at Cross City East Unit from May 11, 2018 to January 11, 2019. Inmate Lee agreed to pay the defendant \$50 for one pack of Newport cigarettes four times. The defendant told Inmate Lee to send two of the money transfers to the name "Jeffrey Thomas Jr." and one to the name "Johnnie Mae Jackson". The fourth transaction was paid in cash. "Jeffrey Thomas Jr" was identified as the defendants friend since childhood, Jeffrey Michael Thomas Jr. "Johnnie Mae Jackson" was identified as the defendant's grandmother. Inmate Lee asked Florida Department of Corrections documented visitor, Ms. Sandra Rolle to send the money. The defendant contacted Ms. Rolle by phone and by text from phone no. to arrange the transactions. Departmental Records reflect that phone no. Sprint Spectrum records indicate that the defendant is the account holder of phone no. On January 1, 2019, Inmate Lee's mother, Ms. Sandra Rolle sent a wire money transfer to the co-defendant in the amount of \$50.00 through RIA Financial. Ms. Rolle cancelled the transaction before it was picked up. On January 4, 2019, Ms. Rolle sent a wire money transfer to the co-defendant in the amount of \$75.00 through RIA Financial. Ms. Rolle cancelled the transaction before it was picked up.
