Your affiant has probable cause to believe, Florida Department of Corrections Employee (FDC), Correctional Officer Amy Lynn Sykes, who works at Liberty Correctional Institution (LCI), violated §944.35(3)(b)2, Sexual Misconduct, between the dates of May 16 and May 17, 2020, when Officer Sykes, while on duty, did engage in the oral penetration of her mouth by the sexual organ of Inmate [REDACTED] in the restroom area of [REDACTED] Wing of Delta Dormitory at LCI.

The fixed wing video camera from the [REDACTED] of [REDACTED] Wing of Delta Dormitory at LCI on May 17, 2020, captured a shadow on the wall which appeared to be inappropriate sexual activity.

On May 20, 2020, your affiant conducted a sworn post Miranda interview with Officer Sykes. Officer Sykes admitted [REDACTED]

Your affiant respectfully submits, probable cause has been established, in that, Amy Lynn Sykes, W/F, DOB: [REDACTED] committed the criminal violation of Sexual Misconduct, in violation of §944.35(3)(b)2 Fla.
