The plant is not constructed in such a manner as to allow floors, walls, or ceilings to be adequately cleaned and kept clean or to be kept in good repair. 21 CFR 117.20(b)(4)

SPECIFICALLY : THERE IS A HOLE IN THE REAR DOOR LEADING TO THE OUTSIDE , THERE ARE SEVERAL SEEMS IN THE CEILING CAUSING TEXTURED FINISHED CEILING TO GAP . REAR DOORS INSTALLED ALLOWING GAP AT BASE LEADING TO THE OUTSIDE .

Failure to pay any permit fees in full will result in the denial of your permit and you may be subject to administrative penalties if you are found operating without a valid food permit, which is a violation of Section 500.12(1)(a), Florida Statutes. If you are found to be in violation of this provision, the Department may impose up to a \$5,000.00 fine against you and/or seek administrative action to close your business.

The Minimum Construction Standards checklist has been used in accordance with 500.12(2)(a) Florida Statutes by the food safety inspector to determine compliance before obtaining a food permit.

Facility is in the process of adding a retail seafood market and adding food service for prepared meals . Facility will be holding whole fish only Sea bass , Mullet and Grunts in refrigerated box of non driving truck on ice . Facility owner will contact the Department of Agriculture before adding changes to the permitted facility type . Primary receiving whole fish only .
