

84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Stacy L. Harris with the Florida Department of Corrections, Office of the Inspector General. Your Affiant has probable cause to believe and does believe on October 19, 2020, at Santa Rosa Correctional Institution Annex, 5850 East Milton Road, Milton, Santa Rosa County, Florida, Inmate Kevin James, DC #980842, an Inmate housed at a State Correctional Institution, did violate Florida State Statute 784.07(2)(b) Battery on a Law Enforcement to wit:

On October 19, 2020, during an attempt to conduct an unclothed strip search of Inmate James, Inmate James turned and struck Correctional Officer [REDACTED] in the left side of the face and head, with a closed fist. [REDACTED] was in full uniform and in the performance of his duties at the time of this incident.

In his digitally recorded, sworn statement, [REDACTED] indicated [REDACTED]

In his digitally recorded, sworn witness statement Lieutenant James Beem indicated on October 19, 2020 he was called to assisted with a disturbance in H – Dormitory, Wing 1. While he was monitoring inmates in the bedding area, [REDACTED] directed Inmate James to the bathroom area in order to conduct an unclothed search of his person. Lieutenant Beem then heard a "commotion" coming from the bathroom area and went to assist. Lieutenant Beem observed Inmate James on top of [REDACTED] and he and Officer Collins then secured Inmate James in hand restraints and removed him from on top of [REDACTED]

In his digitally recorded, sworn witness statement Correctional Officer Robert Collins advised on October 19, 2020 he was present in H – Dormitory, Wing 1 where inmates were being unruly. Officer Collins attempted to counsel with the inmates; however, they continued to refuse orders. Officer Collins called for [REDACTED] to report to H – Dormitory for assistance. Upon his arrival, [REDACTED] called Inmate James to the bathroom area in order to conduct an unclothed strip search of his person. Officer Collins heard a disturbance in the bathroom area and when to check on [REDACTED] Officer Collins observed Inmate James on top of [REDACTED] attempting to strike him. Officer Collins and Lieutenant Beem secured Inmate James and removed him from on top of [REDACTED] and escorted him out of the wing. Officer Collins observed [REDACTED]

In his digitally recorded, sworn witness statement Correctional Officer Nicholas Roeske advised on October 19, 2020 he was called to H – Dormitory to assist with a reported physical altercation between an inmate and a staff member. Upon his arrival in H – Dormitory, Officer Roeske observed [REDACTED] on his back with Inmate James on top of him in a struggle. Officer Collins and Lieutenant Beem then secured Inmate James in restraints and removed him from on top of [REDACTED]


Your Affiant respectfully submits probable cause has been established to conclude Inmate Kevin James, DC #980842, did commit the criminal violation of Battery on a Law Enforcement Officer in violation of 784.07(2)(b) Florida Statute, by intentionally striking, with a closed fist [REDACTED] who was in full uniform and in performance of his duties at the time of the incident, while housed at Santa Rosa Correctional Institution Annex on October 19, 2020.
