84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Lee Martin with the Florida Department of Corrections, Office of the Inspector General. Your Affiant has probable cause to believe that between April 7, 2019 and May 23, 2019, at Century Correctional Institution, 400 Tedder Rd., Century, Escambia County, Florida, Certified Correctional Officer Angelina Gibbs did commit (45) counts of the criminal offenses of Introduction of Contraband into a State Correctional Facility, in violation of s. 944.47(1)(a)(1) Fla. State Statute and (45) counts of unlawful use of a two-way communication device when Officer Gibbs did actually and intentionally correspond, via email, with Inmate Kyan Bucknor (DC# L38336) on a cellular phone recovered from Inmate Bucknor's foot locker within the secure perimeter of a State Correctional Facility, which violates Fla. State Statute 934.215, Unlawful use of a Two-Way Communication Device.

Your Affiant took a sworn, recorded statement from Florida Department of Corrections Captain William Stephens who stated on August 1, 2019, while performing a random dorm search, Captain Stephens found a cellular telephone, inside a honey bun that was located inside CENCI A-Dorm, Wing 2 Inmate Bucknor's assigned foot locker. Inmate Bucknor admitted to Captain Stephens that the cell phone was his. Captain Stephens packaged the seized cellular phone, created a chain of custody and sent the phone to the FDC cell phone lab in Tallahassee.

On September 9, 2019, OIG Cell Phone Analyst Tiarra Cousins completed the cell phone extraction and delivered the findings to the Florida Department of Corrections Office of Inspector General.

Officer Gibbs (promoted to sergeant during this investigation) was hired and employed, at Tomoka C.I., on July 1, 2016 and left the Department on May 28, 2019. Inmate Bucknor was housed at Tomoka C.I. from September 20, 2012 until October 31, 2018.

On September 17, 2019, Inspector Lee Martin reviewed the extracted data and found (45) corresponding messages between Officer Gibbs and Inmate Bucknor. Messages occurred while Officer Gibbs was gainfully employed as a sworn correctional officer for the State of Florida. All messages were conducted while Inmate Bucknor was an incarcerated inmate within the Florida Department of Corrections. Officer Gibbs used the email address GIBBS07@GMAIL.COM; the email is the same email address listed for Officer Gibbs within her State of Florida Human Resources Contact Profile which was filled out by Officer Gibbs. The cellular phone number used by Inmate Bucknor was 386-212-4437; this is the phone number assigned to the phone seized by Captain Stephens from Inmate Bucknor's foot locker.

The following are excerpts from the cell phone's extraction that show a relationship between Officer Gibbs and Inmate Bucknor:



The above correspondence, from Officer/Sergeant Gibbs to Inmate Bucknor detailed several undeniable truths including the following: On April 15, 2019, Officer Gibbs was working the control room at Tomoka C.I. and stated in an email to Inmate Bucknor, that she was working the control room; former Officer, now Sergeant Gibbs was working the control room on May 5, 2019 and stated in the email that another officer wanted “the control room”; On May 8, 2019, Sergeant Gibbs was working the control room at Tomoka C.I. and stated in an email to Inmate Bucknor, that she was “served my papers today at work.”; On May 17, 2019 Sergeant Gibbs was working Tomoka C.I. Control room and emailed Inmate Bucknor that she was “staying in the control room” and “about to go to count.”

Your Affiant respectfully submits probable cause has been established to conclude former Correctional Officer Angelina Linnett Gibbs, date of birth [REDACTED] did commit the criminal violation of Introduction of Contraband into a State Correctional Facility, in violation of Florida Statute Chapter 944.47(1)(a)(1) and Unlawful use of a Two-Way Communication Device, in violation of Florida Statute Chapter 934.215, when she electronically transmitted unauthorized, written communication from a communication device to a contraband cellular device possessed by an inmate housed at Century Correctional Institution, located in town of Century, Escambia County, Florida.
