AT THE TIME OF THE INCIDENT, JONATHAN CALLAWAY (DEFENDANT) WAS A STATE CORRECTIONAL OFFICER ON DUTY AS A STATE CORRECTIONAL OFFICER AT EVERGLADES CORRECTIONAL INSTITUTION.
