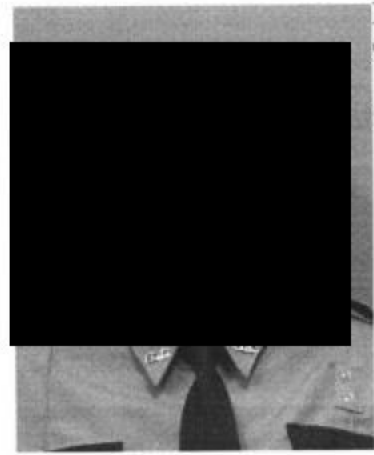
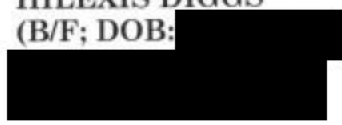

Former Correctional Officer Hilexis Diggs, between January 10, 2020 and May 26, 2020, in the County of Holmes and State of Florida, committed the offense of Introduction of contraband (communication) contrary to Florida Statutes 944.47(1)(a)1 (Third degree FELONY), and

Former Correctional Officer Hilexis Diggs, between January 10, 2020 and May 26, 2020, in the County of Holmes and State of Florida, committed the offense of Unlawful use of two-way communication device contrary to Florida Statutes 934.215 (Third degree FELONY), and

Former Correctional Officer Hilexis Diggs, between January 10, 2020 and May 26, 2020, in the County of Holmes and State of Florida, committed the offense of Interference with Prisoners (**3 counts**) contrary to Florida Statutes 944.39 (Second degree MISDEMEANOR).



84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Senior Inspector Janine Knight of the Office of the Inspector General, Florida Department of Corrections [FDC].

Your Affiant has probable cause to believe former Correctional Officer Hilexis Diggs [Ms. Diggs], in the County of Holmes and the State of Florida, did commit the criminal offenses of Introduction of Contraband into a State Correctional Institution (Electronic Communication), in violation of s. 944.47 (1)(a)(1) Florida Statute, when Ms. Diggs did actually and intentionally introduce, through unauthorized channels, into the secure perimeter of a State Correctional Institution, electronically transmitted and/or recorded communication, images, and/or videos to Inmate Yves Saintyl DC #N20937 [Inmate Saintyl], who was housed at Holmes Correctional Institution [Holmes CI], Holmes County, Florida. Probable cause also exists Ms. Diggs did commit the criminal offense of Unlawful Use of a Two-way Communication Device, in violation of s. 934.215 Florida Statute, when Ms. Diggs used an electronic communication device to introduce contraband communication to Inmate Saintyl, housed at Holmes CI. Lastly, Ms. Diggs committed three counts of the criminal offense of Interference with Prisoners, in violation of s. 944.39 Florida Statute, when Ms. Diggs intentionally engaged in a personal relationship with an inmate housed at Holmes CI, and while doing so allowed the inmate to violate laws of the State of Florida and rules of FDC. Ms. Diggs applied for visitation under a name that was not her own, and Ms. Diggs used a name which was not her own to engage in electronic communications and video visitations via Jpay with Inmate Saintyl.

On November 8, 2019, Ms. Diggs completed an application for employment with FDC for the position of Correctional Officer. On her application, Ms. Diggs marked the box "no" indicating she did not have any business or personal relationship with anyone incarcerated with or under the supervision of FDC. On November 25, 2019, during her employment verification, Ms. Diggs was provided another opportunity to disclose any business or personal relationship she had with anyone under the supervision of or incarcerated with FDC and again Ms. Diggs denied any such relationship and signed a form indicating she had no relationship to disclose. Former Correctional Officer Diggs began her employment with FDC at Holmes CI as a Correctional Officer on or about December 6, 2019.

On or about February 11, 2020, (prior to Ms. Diggs' termination) Sergeant Benjamin Taylor [Sergeant Taylor] submitted an incident report which indicated Ms. Diggs entered B1-dormitory, where she was not assigned to work, near shift change time. Ms. Diggs went to Inmate Saintyl's bed, gave him something, then exited the dorm. A copy of a ripped note was attached to Sergeant Taylor's report. The content of the note referenced information associated with a cellular device.

Ms. Diggs submitted an incident report concerning matters Sergeant Taylor reported for February 11, 2020, on which she admitted going into B1-dormitory and to Inmate Saintyl's bed. Ms. Diggs said she woke Inmate Saintyl and asked him about a book, then exited the dormitory.

Your Affiant reviewed video for B1-dormitory at Holmes CI date stamped February 11, 2020 and observed Ms. Diggs entered the dorm, woke Inmate Saintyl, gave him something, then departed the dorm. Inmate Saintyl was then seen on his bed looking at something prior to placing something in his waistband and going to the dormitory restroom, where there [REDACTED]

On March 18, 2020, Inmate Saintyl provided a sworn recorded statement during which Inmate Saintyl admitted Ms. Diggs gave him a note (on February 11, 2020) but denied Ms. Diggs brought him any other contraband.

On January 21, 2020, (while Ms. Diggs was employed by FDC) JPay account #24954471 was opened with the name "Chante Hill", date of birth: [REDACTED], telephone [REDACTED], address [REDACTED], and email: ChanteHill19@gmail.com. Around February 14, 2020, the name on the account was changed from "Chante Hill" to "Latrice Saintyl". Sometime after February 14, 2020, the account owner's details were changed to the name "Alexiante Winston", date of birth [REDACTED], telephone [REDACTED], address [REDACTED] but the email address remained as chantehill19@gmail.com.

Review of payment information and IP address information associated with Jpay customer ID #24954471 indicated the account was paid for and used by Ms. Diggs to communicate with Inmate Saintyl at Holmes CI both while she was employed with FDC and after

her termination from FDC employment. The Jpay records revealed during Ms. Diggs' employment with FDC at Holmes CI (December 2019 through February 13, 2020), Between January 21, 2020 and February 13, 2020, Ms. Diggs used Jpay account #24954471 to send one hundred and thirty-eight (138) and receive one hundred and thirteen (113) unauthorized electronic communications with Inmate Saintyl. Ms. Diggs also sent Inmate Saintyl photographs. Inmate Saintyl was incarcerated at Holmes CI and under the supervision of the FDC during the timeframes the communications were exchanged. The content of the unauthorized electronic communication was sexually explicit and romantic in nature. Additionally, clear photographs of Ms. Diggs face and a photograph of a tattoo which said "Saintyl" which was located on Ms. Diggs' right foot were sent using the account. JPay account #24954471 sent a total of 115 virtual stamps to Inmate Saintyl through the JPay service during the following dates while Ms. Diggs was employed at Holmes CI: February 2, 3, 6, 9, and 13, 2020.

Review of the communication exchanged between JPay account #24954471 (Ms. Diggs) and Inmate Saintyl indicated (while Ms. Diggs was employed as a Correctional Officer at Holmes CI), she was getting a divorce to be with Inmate Saintyl, whom she planned to have children with. Inmate Saintyl asked Ms. Diggs to meet with his family and obtain something to bring to him. Ms. Diggs indicated in messages she had met and spent time with Inmate Saintyl's parents and daughter. On February 11, 2020, Ms. Diggs told Inmate Saintyl she had a surprise for him and on February 12, 2020, Ms. Diggs said she needed some information and then everything would be handled. Later the same date Inmate Saintyl sent a message he was in confinement and Ms. Diggs responded she had been fired. On February 13, 2020, Ms. Diggs sent a message to Inmate Saintyl saying she, "let US down being careless. I wasn't about to let nobody tax my husband when he got me, I could've waited but nope I couldn't be patient." On or prior to February 17, 2020, Ms. Diggs had Inmate Saintyl's name tattooed on her foot and sent him a photograph through Jpay messages. Between February 10, 2020 and March 13, 2020, Ms. Diggs used Jpay account #24954471 to provide various contact information to Inmate Saintyl to include: telephone number [REDACTED]; telephone number [REDACTED] which she indicated was listed under "Latrice Saintyl"; and address: "Latrice Saintyl, P.O Box 654, Daleville, AL 32322". In messages sent to Inmate Saintyl from Jpay account #24954471, Ms. Diggs told Inmate Saintyl, she had used other Jpay accounts which were not in her name or belonged to other persons to communicate with, send money to, and attempt to set up video visitations with Inmate Saintyl.

On March 10, 2020, Inmate Saintyl told Ms. Diggs in a message sent to Jpay account #24954471, "o in please do me a favor stop changing yo name on jpay I don't kno witch one to write u doing all this dumf a** sh*t." Ms. Diggs responded, "the only reason o changed my name is because I don't got shit to hide nomore and that's my damn name chante is not I changed my email address as well dummy but I guess you don't see that. I resigned so I could be with you in PEACE even when they offered me my job back I said NO cause I love you." On March 11, 2020, Ms. Diggs told Inmate Saintyl "when all that shit took place I felt like my world was over...I know I was willing to do anything in the world to make you happy all this took placed on my scheduled day off. I called Ma and said I'm going to work bae talking crazy and I just feel like if he see me everything would be better but I was wrong."

On March 18, 2020, Inmate Saintyl provided a sworn recorded statement during which he said he met Ms. Diggs during January 2020. Inmate Saintyl said he did receive Jpay email messages from Ms. Diggs while she was employed at Holmes CI as a Correctional Officer. Inmate Saintyl said Officer Diggs had also met his daughter and family.

On March 11, 2020, Ms. Diggs told Inmate Saintyl in messages sent from Jpay account #24954471 she had submitted two (2) visitation forms for her (Ms. Diggs) to be able to visit with Inmate Saintyl one was in her own name and one was in the name "Alexiante Winston." Inmate Saintyl responded and asked if Ms. Diggs told the institution she use to "work here" because Inmate Saintyl had been told Ms. Diggs could not visit for 6 months if she had quit and a year or more if she had been "fired." Ms. Diggs responded the papers (for her termination) were "typed like I was dropped from the training program for establishing a relationship."

On March 16, 2020, (after her employment was terminated) Ms. Diggs completed and submitted (to FDC) an application for visitation to Inmate Saintyl who was housed at Holmes CI. On her application, Ms. Diggs disclosed she had been an employee of FDC, she was Inmate Saintyl's "friend" and she met Inmate Saintyl while at "work". On the same date, Ms. Diggs completed and submitted a second application for visitation privileges to Inmate Saintyl under the name "Alexiante McNair Winston". On the application Ms. Diggs indicated the individual named was Inmate Saintyl's pen-pal, the individual had not worked for the department, and the individual lived at 208 Lowery St, Enterprise, AL 36330. On both applications for visitation, Ms. Diggs signed block #13 which states, "I certify all the information above is complete, accurate, true and that I have read all of the Visitor Rules in Part 2 of this application and agree to follow these rules. In addition, I understand that giving false information is a second-degree misdemeanor and could result in the permanent suspension of my visiting privileges. I acknowledge that a criminal background check will be made." Based on the background check completed for the information submitted on the visitation application for "Alexiante McNair Winston", the information provided was determined to contain a driver's license number not associated with the name given on the application. Both applications for visitation were denied.

On March 10, 2020, (after her employment was terminated) JPay account #25298254 was opened with the name "Hilexis Saintyl, date of birth [REDACTED] telephone [REDACTED], address [REDACTED] and email: Hilexismceachin90@gmail.com. The address, date of birth, and first name provided for Jpay account #25298254 matched those provided by Ms. Diggs, on her background investigation form and correctional officer supplemental application and willingness questionnaire forms she signed on November 18, 2019. During her employment with FDC, Ms. Diggs provided her contact telephone number as the same one found listed on Jpay account #25298254. The account was used by Ms. Diggs to communicate with Inmate Saintyl at Holmes CI after Ms. Diggs left employment with the FDC. Ms. Diggs used the account to send Inmate Saintyl messages and clear photographs of her face.

Jpay databases showed payments for Jpay account #24954471 and Jpay account #25298254 were both paid for using electronic payment methods associated with the names: Hilexis Diggs and Hilexis Dunlap. Additionally both accounts used the same IP

addresses for a Spectrum Internet Service Provider in [REDACTED] when the accounts sent communication to Inmate Saintyl.

On April 27, 2020, Ms. Diggs used Jpay account #25298254 to send a message to Inmate Saintyl advising she was denied visitation rights with Inmate Saintyl and that meant they could not get married.

On March 17, 2020, Inmate Saintyl submitted an Inmate Telephone Agreement and a telephone bill for Spectrum account #202-105736710-001 to Holmes CI Classification department for a telephone number to be added to his calling list for his "Fiancé" "Latrice Saintyl". Details provided for the individual were: address [REDACTED]; telephone number [REDACTED]. The associated telephone bill from Spectrum for "Latrice Saintyl" with telephone number [REDACTED] had a billing date of February 2, 2020 and had been an active account for at least one month prior to the billing date. The address and middle name "Latrice" matched those found in internal records provided to FDC by Ms. Diggs as her contact information. The Spectrum account was opened on or prior to January 2, 2020, and the Spectrum telephone bill was printed during the timeframe Ms. Diggs was employed as a Correctional Officer at Holmes CI. The telephone number on the Spectrum account was the same telephone number provided when the user of Jpay account #24954471, updated their account details with the name "Alexiante Winston"

Beginning on March 13, 2020 (after her employment was terminated) Ms. Diggs began to use JPay account #25298254, to exchange messages with Inmate Saintyl. During those messages, Inmate Saintyl told Ms. Diggs to use his sister's name and set up an account so he could have video visitation with her. On March 14, 2020, Ms. Diggs said she would get the required information to attempt to set the account up. On April 7, 2020, Ms. Diggs told Inmate Saintyl he needed to talk to his mother and sister and tell them Ms. Diggs needed the information so Ms. Diggs and Inmate Saintyl could see one another on video visitation. On April 9, 2020, Ms Diggs said she was happy she could video visit with Inmate Saintyl now.

On April 9, 2020, (after Ms. Diggs as terminated from FDC employment) Jpay account #25503370 was created with the name "Monique Saintyl", date of birth: [REDACTED], telephone [REDACTED] address [REDACTED], and email: Saintylmonique@gmail.com. The telephone number provided for this account was the same as the one provided for Jpay account #25298254. The account was used only to engage in video visitation with Inmate Saintyl. The only electronic payments made for Jpay account #25503370 were made using cards bearing the name "Hilexis Diggs." During at least six (6) of the video visitation sessions, violations of department policy were identified, to include the female visitor exposing her breasts to Inmate Saintyl during multiple video visitation sessions. Screenshots of the visitor's face and upper torso areas were taken during the video visitation sessions, purported to be of visitor "Monique Saintyl". Your Affiant reviewed the images and determined the person in the screenshots to be Ms. Diggs. Ms. Diggs used Jpay account #25503370 on the following dates (after her employment was terminated) April 25 and 30, 2020 and May 8, 11, 23, and 26, 2020 to visit with Inmate Saintyl under the false name of "Monique Saintyl."

Holmes CI Warden Addison Summers (Warden Summers) advised Correctional Officer Diggs did not disclose Inmate Saintyl was her relative or an individual whom she was in a personal or business relationship with. Warden Summers further advised he had not received or approved any requests for communication with or visitation to any FDC Inmate(s) from Correctional Officer Diggs.

Your Affiant, submits probable cause is established that Former Correctional Officer Hilexis Diggs, did commit the criminal violation Introduction of Contraband (Communication) into a State Correctional Institution, in violation of S. 944.47 (1) (a)(1) Florida Statute when Hilexis Diggs did actually and intentionally digitally transmit unauthorized written and recorded communications into the secure perimeter of a State Correctional Institution (Holmes Correctional Institution, Holmes County Florida) to Inmate Yves Saintyl DC #N20937.

Your Affiant respectfully submits probable cause has been established that Former Correctional Officer Hilexis Diggs did commit the criminal offense of Unlawful Use of a Two-way Communication Device, in violation of S. 934.215 Florida Statute, when Hilexis Diggs used an electronic communication device to introduce electronic contraband communication and images to Inmate Saintyl who was housed within a State Correctional Institution (Holmes Correctional Institution, Holmes County Florida).

Your Affiant respectfully submits probable cause has been established that Former Correctional Officer Hilexis Diggs did commit three (3) counts the criminal violation of Interference with Prisoners, in violation of S. 944.39 Florida Statute, when Hilexis Diggs engaged in a personal relationship with Inmate Saintyl who was under the supervision of the Florida Department of Corrections at Holmes Correctional Institution (Holmes County Florida) and while doing so allowed Inmate Saintyl to violate laws of the State of Florida and rules of the Department of Corrections. Additionally, after her termination from employment, Ms. Diggs attempted to obtain visitation privileges to Inmate Saintyl by submitting an application for visitation privileges, using the name "Alexiante Winston." Finally, Ms. Diggs used a Jpay account #25503370 under the name "Monique Saintyl" to engage in video visitations with Inmate Saintyl.

Your Affiant requests an arrest warrant be issued for Hilexis Latrice Devion Diggs, DOB [REDACTED] [REDACTED] for one count of a violation of S. 944.47 (1)(a)(1), the laws related introducing contraband communication; one count of a violation of S. 934.215, the laws related to the unlawful use of two-way communication; and three counts of a violation of S. 944.39 the laws related to the interference with prisoners.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
