Your Affiant is Inspector Chris McGauley with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Correctional Officer Mary Ware (Officer Ware) who currently works at Madison Correctional Institution (MCI). Your Affiant has investigated Official Misconduct that involved Officer Ware.

Warden Amelia Hill (Warden Hill) received an email correspondence containing allegations of fraud. In the correspondence, the dates of November 1 & 4, 2021 were specifically identified that Officer Ware falsified her timesheet on KRONOS (system used to maintain official record of hours worked) with the assistance of Correctional Officer Lieutenant Ramon Dansey (Lieutenant Dansey).

Warden Hill and Assistant Warden Jared Cox (AW Cox) were interviewed and testified similarly that after video was reviewed, Officer Ware was seen on November 1, 2021 and November 4, 2021 reporting for work approximately one (1) hour or one and one-half (1 ½) hours, respectively, after the time she was manually clocked in by Lieutenant Dansey. Officer Ware's position was located inside the secure perimeter and there was no reason for Officer Ware to be outside of the institution several hours before entering the secure perimeter.

she was in a personal relationship with Lieutenant Dansey she invoked her rights to remain silent and the interview was ended.

Lieutenant Dansey was interviewed post-Miranda and denied having any knowledge or involvement in falsifying Officer Ware's KRONOS timesheet. Lieutenant Dansey indicated that Officer Ware requested him to enter her time manually into KRONOS because she forgot to clock herself in. Lieutenant Dansey was not present when she arrived to work and entered the time from Officer Ware's word.

Your Affiant reviewed of video from the Control Room, it showed Officer Ware enter the institution on November 1, 2021, at 11:34 am (manually clocked in at 10:15AM) and on November 4, 2021, at 11:12 AM (manually clocked in at 10:15AM). Officer Ware is observed coming through the gate with her belongings (jacket, lunch bag, etc) and it appears she is just reporting to work.

Your Affiant respectfully submits probable cause has been established Officer Ware did commit the violation of one (1) count of Official Misconduct in violation of § 838.022(1)(a) in Madison County, Florida, Madison Correctional Institution on November 1, 2021, and November 4, 2021.

Your Affiant respectfully requests a warrant be issued for Officer Ware for one (1) count of Official Misconduct in violation of § 838.022(1)(a).

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
