The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:
On the 4th day of August 2022 at 5:30 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Law Enforcement Inspector Kenneth Clay with the Office of Inspector General – Florida Department of Corrections.

On August 4, 2022, at Jefferson Correctional Institution (JCI), the Defendant, Dawn Oldham (Ms. Oldham) violated Florida State Statute by committing the criminal offense of: Conspiracy to Introduce Contraband and Possession of Contraband. Ms. Oldham arrived at the JCI to visit her son, Inmate Billy Buchanan, DC#970577. Upon her arrival, Ms. Oldham then placed her personal belongings in her trunk, a black Chevrolet Camaro, bearing Florida tag#NLB168. Ms. Oldham then proceeded to the JCI Control Room for visitation.


Prior to Ms. Oldham's arrival, intelligence was received indicating that Ms. Oldham may be conspiring to introduce illegal contraband into JCI, namely Suboxone. Ms. Oldham was conspiring with another inmate and that inmate's mother to introduce contraband. Based on the intelligence, an operation to interdict the contraband was established. The Jefferson County Sheriff's Office Canine (K-9) deputies (Deputy Dustin McCoy and Wren Johnson) were contacted who conducted a "free-air" search of the vehicle. Dep. McCoy's K-9 alerted to the presence of narcotics (documented under JCSO Case# 2022-001312) contained within the vehicle. A consensual search of the vehicle was conducted with Ms. Oldham agreeing to the search. Upon the conclusion of the search, a small brown package was located on the exterior of the vehicle right under the rear bumper of the car. Your Affiant was present during the above activity.

Senior Inspector Maria Fender assisted in this case by conducting a recorded, post-Miranda interview. When shown the item, Ms. Oldham

Your Affiant respectfully submits, probable cause has been established in that, Dawn J. Oldham committed the criminal violations of: Conspiracy to Introduce Contraband – Controlled Substance in violation of Florida State Statute §777.04(3)/944.47(1)(a)(4) and Possession of Contraband – Controlled Substance in violation of Florida State Statute §944.47(1)(c), at Jefferson Correctional Institution, in Jefferson County, Florida.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
