

Your Affiant respectfully submits probable cause has been established that inmate Ben Dortch did commit two counts of the criminal violation of Attempted Second Degree Murder, in violation of 782.04(1)(a)2./(777.04(1) Fla. Statute, Possession of Contraband in a State Correctional Facility in violation of 944.47(1)(c), Fla. Statute, and Resisting officer with violence in violation of 843.01, Fla Statute, while in the custody of the Florida Department of Corrections and while housed at Calhoun Correctional Institution located in Calhoun County, Florida, when he punched and stabbed [REDACTED] and [REDACTED] with the intent to kill them with an improvised weapon .
