The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law:
 On the 18TH day of DECEMBER at 11:00 AM PM (Specially include facts constituting cause for arrest)
 Your Affiant is Inspector Heather Whitfield with the Office of Inspector General for the Florida Department of Corrections. The defendant is Officer William Connor (Officer Conner) who was employed at Columbia Correctional Institution-Annex. Your Affiant has conducted an investigation into Trafficking in MDPV, and Introduction of MDMA and Suboxone on a state institution.



On December 18, 2022, Officer Connor entered a secure correctional facility and proceeded through the search procedures. Officer Connor's person was searched by staff after passing through the metal detector at which time staff recovered an object covered in black electrical tape and concealed in a latex glove. Upon further inspection the object was white powder packaged in a clear plastic bag which field tested positive for MDPV commonly known as Flakka. The white powder weighed 120 Grams. Also in the package was one clear bag of a light purple powder which field tested positive for MDMA and weighed 2 Grams and 20 Suboxone Strips (Orange in color) which were clearly labeled with N8.

A post Miranda interview was conducted with Officer Connor, Officer Connor admitted that the object found came from his jacket but denied having any knowledge of the contents of the object. Officer Connor indicated that a friend borrowed his truck the previous day and his jacket was left in the truck.

Your Affiant respectfully submits probable cause has been established indicating Officer William Connor did commit the violation of Trafficking in MDPV in violation of Florida Statute 893.135(1)(k)(1)(c) and Introduction of MDMA and Suboxone in violation of Florida Statute 944.47(1)(a)(4) in Columbia County, Columbia Correctional Institution - Annex on December 18, 2022.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
